### IS THERE A COST TO TAKE THE NS0-172 FLEXP0D SALES EXAM?

There is a charge for taking the NS0-172 Flexpod Sales exam. Please confirm the details with [Pearson VUE](#) when you register for the exam.

### TO ACHIEVE ACCREDITATION, DO I NEED TO TAKE THE WEB-BASED COURSE, OR CAN I SIMPLY TAKE THE EXAM?

You only need to pass the NS0-172 exam to achieve the Cisco and NetApp FlexPod Sales Accreditation. Completing the web-based training will help prepare you to take the exam. The web-based training is offered at no-charge.

### HOW DO I PREPARE FOR THE FLEXP0D CERTIFICATIONS AND ACCREDITATION?

We recommend that you take the training listed for each specific program to prepare to take the exam.

### ONCE I HAVE PASSED MY NS0-170 FLEXP0D DESIGN EXAM OR NS0-171 FLEXP0D IMPLEMENTATION AND ADMINISTRATION EXAM, WILL I RECEIVE A CERTIFICATE FROM PEARSON VUE?

Yes. Once you have passed these exams and achieved certification, you will receive a certificate from NetApp.

### WILL MY ACCREDITATION/CERTIFICATION AUTOMATICALLY BE ADDED TO THE NETAPP SYSTEM FOR COMPLIANCE REPORTING PURPOSES?

Yes. Once you have passed your exam and achieved certification or accreditation, the results will be automatically sent to the NetApp system.
